- 1.) Meeting called to order by Town Manager Victoria Forkus at **7:00 pm**.
- 2.) Nominations for Chairman of the Interlocal Board for the meeting:

- 3.) Review and accept the minutes from January 30, 2019.

- 4.) At the January 30 meeting, the Board requested that Chief Jarvis send out letters to those people who are not paying their bills for ambulance transport services provided to them, and to advise these people that at a minimum they had to set up a payment plan with JMRF&RD's ambulance billing company, Medical Reimbursement Services (MRS), and if they did not, then their account would be turned over to a collection agency. A copy of the letter sent out is included with this agenda.

Since the first of March, MRS has been sending out the letter for the department. Each letter that is sent out is scanned with a copy emailed to Chief Jarvis.

To date, since the letters started going out in the beginning of March, 21% of the delinquent account money has been paid. The current amount owed is \$8,695.03. The amount owed as of December 31st was \$10,983.80.

- 5.) Because most of the delinquent account holders are still not paying what they owe following the receipt of the letter from the department, at this point there is no other choice but to turn the accounts over to a collection agency.

MRS has provided the names of two collection agencies – Thomas Agency in Portland, and FFR (First Financial Resources) in Massachusetts. MRS recommends FFR because they educate the delinquent account holder on credit and what it can do for you.

Chief Jarvis requested information from both collection agencies. Only FFR responded to the request.

The information provided by FFR is included with this agenda.

Board reviewed First Financial Resources, Inc. proposal
